Dear Ms. Cole:

I am writing as requested by Lisa Bennett concerning the continuing need for confidential treatment of certain documents listed in Ms. Bennett's letter to me date January 22, 2009, a copy of which is enclosed for your ready reference.

Of the documents listed in Ms. Bennett's letter, the pending requests for confidential treatment can be withdrawn with respect to all but the following documents:

The explanation of the reason for the extension is that this document shows natural gas RFP information concerning a long-term contract that extended through December 2008. This shows recent terms and conditions, pricing, suppliers, volumes and who was selected for the long-term contract. Owing to the recency of the information, disclosure of this information at any time over the next 18 months would provide potential bidders with recent information concerning what Tampa Electric is willing to settle for in the nature of a long-term natural gas supply contract. Public disclosure of this information would harm Tampa Electric's ability to contract for goods and services on favorable terms. Accordingly, this information is entitled to confidential treatment under Section 366.093, Florida Statutes.


