Per FPSC Staff's request Aqua Utilities Florida, Inc. (Aqua) has researched those customers/connections being served by Aqua for water and/or wastewater services whose property was located outside the existing FPSC Approved Certificated areas covered within the above dockets.

In 2006 Aqua conducted a conversion of its billing system from Avatar to Banner. The review, for the purposes of meeting Staff's request, was conducted on the previous system - Avatar. Specifically, Aqua staff identified the "Meter Set Date" (MSD) as the date the initial meter was installed for the properties in question.

From our review of all the systems associated with the above mentioned dockets. the connections in question, and the MSDs, Aqua has determined that all connections in question were being served prior to Aqua purchasing the systems in question.
