On August 3, 2007, KW Resort Utilities Corporation applied to the Florida Public Service Commission (PSC) for increased wastewater service rates to its customers in Monroe County, Florida. That Application also requested approval of interim rates.

By Commission Order No. PSC-07-0812-PCO-SU issued on October 10, 2007, the PSC granted interim rates, collected subject to refund, pending the Commission's decision regarding final rates.

After a full hearing on the issues raised, the Florida Public Service Commission issued its Final Order No. PSC-09-0057-FOF-SU on January 27, 2009 authorizing a portion of the requested increases in wastewater rates designed to allow KW Resort Utilities Corporation the opportunity to recover costs for providing service and a reasonable rate of return on its investment in facilities necessary to provide such wastewater service. That Order has now become final.

The increased rates approved by the Commission are effective for meters read on or after thirty (30) days from February 27, 2009.

The new rates for wastewater service are listed on the back of this customer notice.

As a result of the Commission's final action, they also required that the Utility refund 1.85% of wastewater revenues collected under interim rates. Those refunds are required to be made, with interest, in accordance with Commission Rule. The Utility will be providing credits on each customer's next bill, which will include those refunds.
