

Enclosed is our response to Staff's Data Request regarding the cost of providing inmate telecommunications services for Pay Tel Communications, Inc. of the Southeast ("Pay Tel")in the State of Florida. Thank you for the opportunity to provide this information and for all of Staff's hard work in the above referenced proceeding.

As you know, our company provides inmate telecommunications services within the State of Florida. The Total Sales figures that we have provided in response to Staff's Data Request include an for a billing recovery fee. We were compelled to implement this fee several years ago, when BellSouth/AT&T dramatically increased the billing and collection rates that they charge to companies such as ours for billing our calls. Rather than increase the local collect call rates to the entire customer base, we felt that it was more equitable to allocate the increased expense only to those customers who chose to pay for their calls utilizing LEC billing, rather than other available billing/payment options. In this regard, Pay Tel offers its customers alternative billing options that would allow customers the use to our services at a discount without the increased LEC billing costs.


