Dear Ms. Cole:

According to FPSC Rule 25-17.086, "Periods During Which Purchases are Not Required", Progress Energy Florida (PEF) is providing notice to the Florida Public Service Commission that PEF transmission path RECK - FPC was limited to 0MW of ATC for 5/14/2009 through 5/15/2009 during peak period. During this period, Auburndale was not able to deliver non-firm power to PEF.

In order to determine available ACT, contingencies studies were performed on the system on 5/14/2009, which confirmed contingencies seen in previous studies. With multiple planned outages, PEF has calculated 132 MW of firm ATC for the path RECK - FPC. There is an existing transmission service request, reference number 72969898 which is a Yealy Firm Network reservation for 132 MW from 1/1/2009 to 1/1/2014 for RECK- FPC. This pre-existing firm reservation was not affected by the outages during this time period.
