On November 10, 2008, Utilities, Inc. of Eagle Ridge (the "Utility"), completed its application to the Florida Public Service Commission (the "Commission") for increased wastewater service rates, in which it requested a permanent rate increase of 42.8% for wastewater service.

By Proposed Agency Action Order No. PSC-09-0264-PAA-SU ("PAA Order"), issued April 27, 2009, the Commission approved a rate increase of 31.25% for wastewater service. In addition, the Commission approved revised miscellaneous service charges. These rates and charges were designed to allow the Utility the opportunity to recover its reasonable and prudent costs for providing service, and a reasonable rate of return on its investment in facilities necessary to provide such water and wastewater service. The PAA Order was not protested within the protest period, and became final by Order No. PSC-09-0363-CO-SU, issued May 26, 2009.

The increased rates and charges are effective for service on or after June 1, 2009.

The rates prior to filing, the Commission-approved wastewater rates, and approved revised miscellaneous service charges are attached to this customer notice.
