On June 5, 2009, the Commission received a request from USD CLEC, Inc. (“USD”) to cancel its authorization to provide intrastate telecommunications services in Florida and any associated tariffs. The Commission acknowledged receipt of USD’s request on June 5, 2009 and assigned the matter the above-referenced docket number.

Per the request of Staff, USD hereby further informs the Commission that the dissolution of USD is pending Bankruptcy Court approval and will occur subsequent to the liquidation and disbursement of other classes of assets. Because of the bankruptcy, there are no funds available, and USD therefore requests that the Commission write-off any unpaid regulatory assessment fees.


