This letter is written on behalf of TLP Water, Inc., and pursuant to conversations we have had by phone, as well as e-mail correspondence, regarding the initial monthly water service rate to be charged by TLP Water, Inc. It is my understanding that, in order to resolve objections to the issuance of a Certificate to TLP Water, Inc., or to setting its initial water service rate at \$39.00 per month, PSC staff have requested that representatives of the parties provide this letter indicating there is no objection to such issuance or rate. While TLP Water, Inc., has filed an application for a Staff Assisted Rate Case to allow its rate to be set at a level higher than \$39.00, it has no objection to its initial water service rate being set at \$39.00 per month for purposes of issuance of the Certificate. 
