THIRTEENTH NOTICE OF INTENT TO REQUEST CONFIDENTIAL CLASSIFICATION

Progress Energy Florida ("PEF" or the "Company"), pursuant to Section 366.093, Florida Statutes, and Rule 25-22.006, Florida Administrative Code, files this Notice of Intent to Request Confidential Classification of the portions of the testimony and exhibits of Office of Public Counsel's ("OPC") witness William R. Jacobs, Jr., Ph.D., filed in the above referenced docket. Portions of Dr. Jacobs' testimony, as well as Exhibit WRJ-(PEF)3, contains PEF's confidential information. Mr. Jacobs' testimony and the Exhibit contain confidential competitive business information, the release of which would harm PEF's competitive business interests and violate PEF's contractual confidentiality agreements. Furthermore, this information has previously been provided in response to various requests throughout the discovery process, and at all times PEF has maintained its confidentiality. For these reasons, PEF is requesting that the Commission afford these documents confidential classification.


