**FOURTEENTH NOTICE OF INTENT TO REQUEST  
CONFIDENTIAL CLASSIFICATION**

Progress Energy Florida ("PEF" or the "Company"), pursuant to Section 366.093, Florida Statutes, and Rule 25-22.006, Florida Administrative Code, files this Notice of Intent to Request Confidential Classification of certain documents produced in response to the Florida Public Service Commission's Staff's ("Staff") Fourth Request for Production of Documents (Nos. 22-30 ), specifically number 28. A certain document produced in response to this request contains confidential competitive business information related to the Levy Nuclear Project ("LNP"), the release of which would harm PEF's competitive business. PEF considers this information proprietary and confidential, does not share it with the public, and has at all times maintained its confidentiality. For these reasons, PEF is requesting that the Commission afford these documents confidential classification.

PEF is providing as Exhibit "A" a CD containing the confidential information in question.

Pursuant to Rule 25-22.006(3)(a)(1), PEF will file its Request for Confidential Classification for such confidential information contained therein within twenty-one (21) days of

filing this request.




