PEF'S EIGHTH NOTICE OF INTENT TO REQUEST CONFIDENTIAL CLASSIFICATION

Progress Energy Florida ("PEF" or the "Company"), pursuant to Section 366.093, Florida Statutes, and Rule 25-22.006, Florida Administrative Code, files this Notice of Intent to Request Confidential Classification of certain documents produced in PEF's Response to the Florida Public Service Commission's Staff's ("Staff") Thirty-Second Set of Interrogatories (Nos. 408-441), and Staff's Twenty-Fourth Requests for Production of Documents (Nos. 159-168). Certain documents being provided in response to these requests contain confidential information relating to the Company's competitive interests, the release of which would harm the Company's competitive business interests. For these reasons, PEF requests that the Commission afford this document confidential classification.


