Dear Chairman Carter:

In your letter dated April 29, 2009, you acknowledged that our client, Lindrick Service Corporation (the "Company"), would apply for general rate relief for its water and wastewater systems located in Pasco County, Florida, and approved the Company's request for a projected test year ending December 31, 2010. You also instructed the Company to submit its Minimum Filing Requirements ("MFRs") on or before August 31, 2009. The MFR filing deadline was later extended to September 30, 2009. Despite the Company's diligent efforts, it has not been able to complete compilation of its MFRs within the allotted time. The Company still intends to pursue its rate case before the Commission; however, it also wants to provide the Commission with the most current information available. Therefore, the Company is withdrawing its request for test year approval at this time, and will submit a new request for a test year approval in the near future.


