GAINESVILLE REGIONAL UTILITIES (GRU) AND GAINESVILLE RENEWABLE ENERGY CENTER, LLC (GREC LLC) REQUEST FOR CONFIDENTIAL CLASSIFICATION

GRU and GREC LLC, pursuant to Section 366.093, Florida Statutes (F.S.), and Rule 25-22.006, Florida Administrative Code (F.A.C.), submit this Request for Confidential Classification of certain information in the pre-filed direct testimony of witness Bradley E. Kushner and Confidential Exhibits BEK-2 thru BEK-6. In support of this Request, Petitioners state:

1. On September 18, 2009, Petitioners filed a Notice of Intent to Request Confidential Classification related to certain information in the pre-filed direct testimony of Petitioners' witness Bradley E. Kushner and Confidential Exhibits BEK-2 thru BEK-6 (filed on September 18, 2009). Mr. Kushner's testimony and Confidential Exhibits BEK-2 thru BEK-6 include confidential, proprietary business information reflecting the pricing under the POWER PURCHASE AGREEMENT FOR THE SUPPLY OF DEPENDABLE CAPACITY, ENERGY AND ENVIRONMENTAL ATTRIBUTES FROM A BIOMASS-FIRED POWER PRODUCTION FACILITY by and between GAINESVILLE RENEWABLE ENERGY—CENTER, LLC and the city of GAINESVILLE, FLORIDA d/b/a GAINESVILLE REGIONAL—UTILITIES, dated as of April 29, 2009 (the "PPA"). Disclosure of this information would

renewable energy from other projects being developed by GREC LLC, and would also impair GREC LLC's ability to contract for goods or services on favorable terms. The information for which Petitioners seek confidential classification is confidential negotiated pricing information between GRU and GREC LLC under the PPA, and this information is protected from public disclosure under the confidentiality clause in the power purchase agreement between GRU and GREC LLC. This Request for Confidential Classification has been filed within 21 days after Staff obtained the pre-filed direct testimony of Petitioner's witness Kushner and Confidential Exhibits BEK-2 thru BEK-6, and is therefore timely. Rule 25-22.006(3)(a)(1), F.A.C.

- 2. The following exhibits are included with this request:
 - a. Exhibit A is a table which identifies the information for which Petitioners seek confidential classification and the specific basis for seeking confidential treatment;
 - b. Exhibit B is a package containing two copies of a redacted version of the documents for which Petitioners request confidential classification. The specific information for which confidential treatment is requested has been blocked out by opaque marker or other means;
 - c. Exhibit C is a package containing an unreducted copy of the documents for which Petitioners seek confidential treatment. Exhibit C is being submitted separately in a sealed envelope labeled "CONFIDENTIAL." In the unreducted version, the information asserted to be confidential is highlighted in yellow; and
 - d. Exhibit D is an affidavit of Joshua H. Levine.
- 3. The information described above and identified on Exhibit "A" qualifies for confidential classification under Section 366.093(3), Florida Statutes. GREC LLC is developing
