Mr. Mostrom,

In reviewing the CLEC application, Question 16(b) asked if the company has pending CLEC applications in other states; you answered "15" but did not list the states the company has applied to. Could you please list those states in your email reply. Part of the application's due diligence requires we monitor the company's activities in other states. I also noticed than an FCC search didn't bring up your company name. Have you applied for your licensing with the FCC yet? If so, under what name, maybe I searched it wrong?

I have your resume, but no information/resumes on the other Florida listed company officers: Kirkeide, Martin, or Remsa. Florida requires at least a resume or general paragraph giving information about them professionally and how they are involved with the company requesting certification. All officers of Florida certificated CLEC's are considered responsible for the management of the applying company whether they are directly or indirectly involved in the day to day operations.

Mr. Mostrom, your resume more than meets the managerial criteria, but your technical expertise is not detailed. Are you providing the company with technical expertise or do you have someone else working in the company taking care of that for you? If so, we need that person's resume detailing their technical expertise or a paragraph stating how technical expertise is being managed?

The Financials submitted are complete, though not audited, which requires a signed statement by the CFO & CEO specifically stating they are 'not audited, yet as the CFO and CEO, we testify they are true and correct'.

The Price List looks good, but the the company name needs to be reversed to read as INTERNATIONAL INTEGRATED SOLUTIONS, LLC d/b/a INTERNATIONAL NETWORK SOLUTIONS, LLC throughout the document and delete the effective date. Commission Staff date stamps Price Lists with the effective date once the certification is complete.
