AT&T FLORIDA'S AMENDED NOTICE OF INTENT PURSUANT TO RULE 25-22.006

BellSouth Telecommunications, Inc. d/b/a AT&T Florida ("AT&T Florida"), pursuant to Rule 25-22.006, Florida Administrative Code, files its *Amended* Notice of Intent.

1. On October 27, 2009, AT&T Florida filed its Responses to the Staff of the Florida Public Service Commission ("Staff's") First Set of Interrogatories and First Request for Production of Documents in the captioned docket, along with a Notice of Intent to Request Specified Confidential Classification.

2. The attachment to Item 6(b) to Staff's First Set of Interrogatories and the documents responsive to Item 5¹ of Staff's First Request for Production of Documents contain information that might be considered confidential business information to dPi Teleconnect, L.L.C. ("dPi"). AT&T Florida is now filing this Notice of Intent pursuant to Rule 25-22.006(3)(a), Florida Administrative Code, in order to allow the Commission to take possession of this material without delay. In an abundance of caution, AT&T Florida is protecting the information under this Notice of Intent because it believes that the information might be confidential to dPi. If dPi believes that the information is confidential, dPi will need to file a Request for Specified Confidential Classification in 21 days from the date of the Notice of Intent, i.e. on or before November 17, 2009, to keep this information confidential as AT&T Florida will not be filing a Request for Specified Confidential Classification for same. The original of this
