The Florida Public Service Commission, pursuant to Section 120.54, Florida Statutes, published notice in the January 23, 2009, edition of the Florida Administrative Weekly that it had initiated rulemaking to amend Rules 25-4.002, 25-4.0185, 25-4.023, 25-4.066, 25-4.070, 25-4.071, 25-4.073, 25-4.074, 25-4.083, 25-4.107, 25-4.109, and 25-4.110 and repeal Rules 25-4.046, 25-4.067, 25-4.108, Florida Administrative Code, relating to telecommunications regulation. No request for hearing or written comments were filed concerning the amendment of Rules 25-4.022, 25-4.023, 25-4.071, 25-4.074, 25-4.107, 25-4.109, or the repeal of Rules 25-4.046, 25-4.067 or 25-4.108. These rules were filed with the Secretary of State and became effective on March 26, 2009.

Written comments were received concerning Rules 25-4.066, 25-4.070, 25-4.073, 25-4.110, and 25-4.083. Rule 25-4.0185 could be affected if changes are made to Rules 25-4.066, 25-4.070, or 25-4.073.

On June 24, 2009, SB 2626 was signed into law and will become effective on July 1, 2009. A copy of this law may be accessed at:

SB 2626 amends various sections of Chapter 364, Florida Statutes, and in some cases may affect proposed rules for which written comments were previously submitted in this docket.
