Dear Mr. Tabor:

We received your September 8, 2009 response to the deficiency letter; however, several items listed in the previous deficiency letter have not been provided and additional information regarding portions of your application is needed.

Deficiencies

1. Section 367.045(1) (a), Florida Statutes, and Rule 25-30.030, Florida Administrative Code (F.A.C.), require the utility to provide notice of the application and affidavits that the notice was given to (1) customers, (2) governing bodies and privately owned water and wastewater utilities, and (3) in a newspaper of general circulation. You have provided affidavits of noticing to the governing bodies and privately owned water and wastewater utilities and in a newspaper. However, an affidavit that noticing was provided to existing customers and property owners was not included. Please provide an affidavit that a notice of the utility's application for an original certificate and original rates and charges has been provided to existing customers and property owners.
2. Rule 25-30.033(1)(e), F.A.C., requires evidence that the utility has the financial and technical ability to provide service. You have provided the applicant's personal financial statement as a showing of financial ability to provide service; however, you have not provided evidence of the applicant's technical ability to provide service. Please provide the plant operator's name, license class, and license number and any other information that indicates the applicant's technical ability to provide water service.
3. Rule 25-30.033(1)(j), F.A.C., requires evidence that the utility owns or has access to the long term use of the land upon which the utility treatment facilities are located. The warranty deed that was submitted on September 8th is in the name of A.N.B. Real Estate Investments, Inc., and staff is not clear whether it includes the land on which the utility's treatment facilities are located. Please provide a warranty deed or

other evidence of the utility's long term use of the land on which the utility's treatment facilities are located. The deed or other evidence must be in the utility's name.

4. Rules 25-30.033(1)(l), (m), and (n), F.A.C., require a legal description of the utility's proposed service territory and maps showing the proposed service territory, lines, and treatment facilities. The map provided does not contain a legal description of the proposed service territory. Please provide a map showing the utility's proposed service territory in metes and bounds or quarter sections with a defined point of beginning. In addition, the map provided indicates that all lines and facilities are proposed. Please provide a revised map showing existing and proposed customers, lines, and facilities.
5. Rule 25-30.033(1)(r), F.A.C., requires detailed financial statements (balance sheet and income statement) for Arma Water Service, LLC. (Arma) using the National Association of Regulatory Utility Commissioners (NARUC) Uniform System of Accounts (USOA).

Additional Information

1. When and under what circumstances did the utility begin providing service to its customers without first obtaining a certificate from this agency?
2. Please provide the 2008 tax return for Arma Water Service, LLC. and a depreciation schedule showing the utility assets. Note that the utility's net investment in water facilities (original cost net of accumulated depreciation, contributions in aid of construction, and accumulated amortization) is the basis for determining the allowed return on investment. Further, pursuant to Rule 25-30.570, F.A.C., the value of the distribution system may not be included as utility investment if the utility cannot demonstrate that those assets have been depreciated, instead of written off to cost of goods sold. The utility's application reflected total fixed assets of \$375,700 for the system on Schedule 1A; however, the list of assets submitted totaled \$274,181.63.
3. Rules 25-30.033(1)(t), (u), (v), and (w), F.A.C., require a cost study supporting all proposed rates and charges, including the base facility and gallonage charges, service availability charges, and miscellaneous service charges. The cost study should include schedules showing (1) the projected cost of the existing and proposed water facilities, accumulated depreciation, contributions in aid of construction, and accumulated depreciation, (2) projected operating expenses, and (3) projected capital structure when 80 percent of the designed capacity of the system is being used. The information should be provided using the NARUC USOA. The utility's application and revised information contain inconsistencies with regard to the number of existing and proposed ERCs, the projected expenses, the proposed return on investment, and the basis for the proposed rates and charges. If the utility plans to serve a total of 58 ERCs at design capacity, then the projected assets, depreciation, contributions in aid of construction, operating expenses, return on investment, and the resulting rates and charges should reflect the cost to serve 58 ERCs.
4. How many connections are currently metered? What size are the existing meters?



After reviewing the application in the above referenced docket, staff has identified the following deficiency and additional information needed to complete our review and processing of the application.

Deficiency

1. Territory map. Rule 25-30.035(11), Florida Administrative Code, requires one copy of the official county tax assessment map, or other map showing township, range, and section, with a scale such as 1"=200' or 1"=400', with the proposed territory plotted by used of metes and bounds or quarter sections, and with a defined reference point of beginning. Please submit an official county tax assessment map of the water system and a map of the wastewater system that is consistent with the legal description listed in tariff.

Additional Information

1. The information submitted in the application indicates that the utility has some customers that are water only customers. For those customers that are water only customers, who provides these customers with wastewater service?
2. For wastewater only customers, your tariff provides that the miscellaneous service charge for a violation reconnection is \$20.00 for normal hours and \$25.00 for after hours. Are these the amounts you would charge for a violation reconnection for wastewater only customer?
3. Water Tariff Sheet No. 11.0 reflects a reconnection charge of \$2.00 during regular hours. Tariff Sheet No. 15.1 reflects a violation reconnection charge of \$20.00 during normal hours with a \$2.00 charge penciled in for water customers. Please explain the discrepancies in the amounts listed on the two tariff sheets.

4. Tariff Sheet No. 16.0 reflects a flat charge for wastewater service. Tariff Sheet No. 16.1 reflects a base facility charge and gallonage charge for wastewater service. Please describe the customers to whom these charges would apply.
5. The application includes tariff sheets for grossing up and collecting taxes on contributions in aid of construction (CIAC). Are you charging and collecting gross up taxes?
6. The utility has a service availability policy that allows the acceptance of donated lines and a system capacity charge for water and wastewater service. Do you collect both a system capacity charge and receive donate lines from new customers?
7. What is the capacity of the systems and is the system at build out?
