All three of these were filed in 080001:

#1 Document No. 04846-08, FPUC's agreement for Generation Services with Gulf. Bernie recommended confidentiality by memo dated 2/24/09, but since the original request is dated more than 18 months ago (6/6/08), we need to decide if we still need this document or if it can be returned to the source. If we still need it, I think we should ask FPUC to make a new request that justifies extended classification for more than 18 months.

#2 Document No. 09423-08, FPUC's preliminary list of issues and positions for Marianna (Issue 5).

#3 Document No. 09720-08, FPUC's Prehearing Statement with the Issue 5 number for Marianna.

If I recall correctly, we sent the 2009 Marianna issue/position/PHS documents back to FPUC a couple of weeks ago, so I'm guessing that we should send the 2008 ones back and close the confidentiality requests as "returned to source?" I did a quick document listing search but couldn't find a reference that we might have already sent these back - which doesn't mean we didn't, only that I couldn't find it online.
