## 25-24.516 Pay Telephone Operator Services Rate Caps.

(1) Rates charged any end user by a pay telephone provider, providing operator-service within the pay telephene premises' equipment, shall not exceed the following:
(a) Loeal coin calls the rate ported at the pay telephene station.
(b) Extended area-serviee (EAS) evin calls-arate equivalent the local coin call rate.
(e) Extended calling seope (ECS) ealts the rato equivalent to the lecat coin rate.
(d) $0+$ toll nen-persen-to-persen-a maximum rate of $\$ 0.30$ per minute, plus a $\$ 1.75$
eharge.
(e) $0+$ toll persen to-persen-a maximum rate of $\$: 30$ per-minute, plus a $\$ 3.25$-harge.
(f) $0+$ nen-persen to persen lecal-a rate equivalent to the-loeal coin fate, plus a $\$ 1.75$ charge.
(g) 0 - persen-to-persen loeal-a ratequivalent to the loent coin rate, plus a $\$ 3.25$ eharge.
$(2)$ A pay telephone provider shall not obtain services from an interexchange carrier or an operator service provider unless such carrier or provider has registered with or has obtained a certificate of public convenience and necessity from the Commission.
