Greetings! A question has come up regarding a PEF confidentiality request in 090009. Specifically, PEF filed a request for confidentiality of DN 06699-09 (response to Interrogatory No. 28+NuStart Memo, which seems to also be part of the working papers from an earlier NCRC audit (Audit Control No. 08-248-2-1)). 06699-09 appears to consist of 2 separate previously filed documents with NOIs - 05937-09 (the audit working papers) and 06611-09 (response to Rog 28). The question becomes, should the order grant confidentiality to all 3 documents, or can either/both of the earlier ones be returned to source and the order issued just cover the "combined" 06699?
