## MOTION FOR RECONSIDERATION OF ORDER NO. PSC-10-0656-FOF-WU

O & S WATER COMPANY, INC. ("O & S"), by and through its undersigned counsel and pursuant to Rule 25-22.060, Florida Administrative Code, files this Motion for Reconsideration of Order No. PSC-10-0656-FOF-WU ("Order"), and in support thereof states:

1. The Order initiates an overearnings investigation and requires the escrow of certain funds during the pendency of the Commissions' investigation.

2. On November 10, 2010, O & S entered into an Asset Purchase Agreement to convey all of its water utility assets to the Tohopekaliga Water Authority ("TWA") which is a governmental entity and by law is entitled to Commission approval as a matter of right. The Application for the Commission to approve the transfer will be filed on November 15, 2010.

3. Pursuant to the Asset Purchase Agreement the sale must be closed by December 31, 2010, and a tentative closing date is scheduled for December 8, 2010.

4. In light of the anticipated sale it would not be the best use of the Commissions' or O & S's resources to incur the time and expense of an overearnings investigation.

WHEREFORE, O & S WATER COMPANY, INC., respectfully requests that the Commission reconsider Order No. PSC-10-0656-FOF-WU, and not investigate the earnings of O & S nor require an escrow of revenues collected by O & S.
