

Dear Commission Clerk and Ms. Curry:

Please allow this letter to supplement the filing by Netline Communications Corp. d/b/a "clubip.com" (herein called "Netline") for reinstatement of certification as an interexchange carrier in the State of Florida filed on December 21, 2010. Netline seeks to reinstate its IXC Registration at this time. Netline was previously certified by the Florida Public Service Commission ("Commission") to provide interexchange (IXC) and competitive local exchange services (CLEC) under certificates TX818 and TK095 These revocations occurred on March 23, 2006 (TX818 - Docket 060065)¹ and July 26, 2007 (TK0967)

Docket 07052).2 The reason Netline's certificate were revoked was its failure to timely file and pay annual RAF(s), as well as submit regulatory reporting and responding to Commission Staff information requests as a certified competitive local exchange carrier in Florida. Both investigations involved first time offenses and failures to file and pay. With respect to RAF Assessments due, Netline immediately paid all RAF assessments to the Commission upon becoming aware that outstanding RAF Assessments were due and payable. Unfortunately, penalties had incurred as a part of revocation and Netline not responding in a timely manner. Since the revocations, Netline re-evaluated its services and its need to operate as a CLEC in the state of Florida and how to structure its U.S. and international operations to avoid future issues such as revocations. Netline has decided that it will not offer CLEC services as its core services related to such a certification comprise Interconnected VoIP and VoIP Toll Services. However, Netline does desire to obtain authority to provide interexchange services from the State of Florida pursuant to Chapter 364, Florida Statutes and 25-24.470 F.A.C. to expand its service offerings. To such ends, Netline as a part of this application to reinstate its certification as an interexchange carrier, offers the Commission the amount of \$500.00 in penalties for TK096/ Docket 07052, and \$3,000.00 USD in penalties for TX818/Docket 060065. Payment of these penalties can be made if accepted by the Commission as a settlement in this application. Please advise the undersigned counsel if this is acceptable.³

Likewise, the Commission's staff had raised concern that the reinstatement application and Tariff of Netline listed fictitious that were not on file with the Florida Department of State, Division of

³ Please note that in **Docket No. 090243-TX** for Netline Communications Corp that Netline sought to reinstate both certification as a CLEC and certification as an IXC. This settlement amount was discussed prior to settle matters under that Docket to reinstate the CLEC certification, but Netline was unsure at that time if it desired the CLEC certification. This amount is now offered to reinstate certification only as to IXC services, and to reconcile penalties that may be attached to the company under the past CLEC certification, but not to reinstate CLEC certification.

Corporations. These specifically were "ClubIP.com" and "Ipsmile" which were listed in the application and/or Tariff. The names in question are trademarks of Netline, and since the December 21, 2010 filing of this application, Netline has obtained fictitious name registrations for "ClubIP" with Florida Department of State, Division of Corporations.⁴ Netline has decided to abandon the Ipsmile d/b/a at this time and herein submits an Original and Two (2) copies of it's Tariff that conforms to the requirements of Rule 25-24.485, F.A.C. without the "ipsmile" d/b/a. Should there be any questions as to this Tariff

On behalf of Netline, I ask that the Commission accept the offered settlement of past penalties for first time compliance violations and confirm the Florida fictitious names now held by the applicant that correspond to its original reinstatement application and tariff. 
