STAFF'S FIRST DATA REQUEST

Re: Docket No. 110099-EU - Joint petition for approval of territorial agreement in Bradford County by Florida Power & Light Company and City of Starke.

Dear Mr. Goorland:

By this letter, the Commission staff requests that Florida Power & Light Company (FPL) and the City of Starke (City) provide responses to the following data requests.

1. The petition states that FPL and the City entered into a territorial agreement on February 27, 2009, but did not seek approval by the Commission. With regard to this initial agreement, please explain why the parties did not seek Commission approval and state whether any customers or facilities were transferred as a part of this initial agreement. In addition, please provide a copy of that February 27, 2009 agreement.
2. Please provide a copy of all written notices sent to all affected customers, as well as copies of all customer responses received.
3. Section 2.7 of the agreement states that, "Customers of transferred accounts shall be subject to the deposit policies of the utility receiving the transferred customers." Please provide detailed information regarding whether the 86 affected customers have existing deposits with the respective parties, and whether a deposit will be required once the transfer takes place.
4. Please provide an electronic version, in Microsoft Word format, of the full description of the territorial agreement line found on the map provided as part of the petition.
5. Please provide detailed information regarding when the customers will be transferred and where each is located.
