Enclosed for filing with the Florida Public Service Commission ("Commission") please find an original and one (1) copy of requested revised sheets for Zone Telecom, LLC's ("Zone's") Florida local exchange communications services tariff P.S.C. No. 2. Zone Telecom, Inc. was previously granted authorization as a competitive local exchange carrier in Florida (see authorization granted in Docket No. 030463-TX). Pursuant to Zone's notification letter to the Commission, filed on October 14, 2010, Zone Telecom, Inc., a Delaware corporation, was converted into Zone Telecom, LLC, a Delaware limited liability company on March 24, 2011. Zone also filed a "Change of Information on Regulated Utility" form (by facsimile on July 14, 2011) to update the name on its Certificate No. 8366 in the Commission's system. A copy of Zone's "Change of Information on Regulated Utility" form is also been enclosed with this filing.

Zone has not changed any rates, regulations or conditions of service as a result of this conversion, and the enclosed tariff has been updated only to reflect the company name, address, and contact changes. The following is a brief description of the changes:

- Title Sheet, Page No. 1: Zone's name has been updated in the header, footer and body of the text to reflect the conversion. The Issued and Effective dates in the footer have also been revised.
- Check Sheet, Page No. 2: The page numbers listed on the Check Sheet have been updated to reflect the revisions throughout the tariff. Zone's name has been updated in the header and footer of the tariff to reflect the conversion. The Issued and Effective dates in the footer have been revised as well.
- Check Sheet, Page No. 3: The page numbers listed on the Check Sheet have been updated to reflect the revisions throughout the tariff. Zone's name has been updated


in the header and footer of the tariff to reflect the conversion. The Issued and Effective dates in the footer have been revised as well.

- Application of Tariff provision, Page No. 15: Zone's name has been updated in the header, footer and body of the text to reflect the conversion. The Issued and Effective dates in the footer have also been revised.
- Explanation of Terms, Page No. 103: Zone's name has been updated in the header, footer and body of the text to reflect the conversion. The Issued and Effective dates in the footer have also been revised.


