THE CITY OF MARIANNA'S REQUEST FOR ORAL ARGUMENT

The City of Marianna, Florida ("Marianna" or "City"), pursuant to Rule 25-22.058, Florida Administrative Code ("F.A.C."), hereby requests that the Commission allow oral argument on the motion to dismiss filed by Florida Public Utilities Company ("FPUC") in this docket, and on the City's Response in Opposition to that motion. The City believes that oral argument will aid the Commission in fully comprehending the relationships, and differences, between (a) the facts that establish the City's standing and right to a formal evidentiary hearing and (b) the disputed issues of material fact that the Commission must consider in making its decision on the ultimate issue in this docket, namely, whether to approve FPUC's proposed time-of-use and interruptible rates that are the subject of this docket. The City believes that oral argument would aid the Commission's understanding and consideration of the City's right to a formal proceeding with respect to standards of review applicable to motions to dismiss under Florida law. The City also believes oral argument would enable the Commission to gain a more
