4. Staff also requests that, if the extension is granted, the utilities' rebuttal testimony

related to Staff hedging audit testimony presently due on October 6, 2011, be extended to

October 13, 2011 and that the prehearing statements due October 10, 2011 be extended to

October 17, 2011.

5. Staff Counsel has contacted the aforementioned utilities, and no utilities object to

allowing Staff an extension of time to file its hedging testimony as well as the extension of time

to file rebuttal testimony related to Staff hedging audit testimony and the extension of time to file
