ORDER GRANTING EXTENSION OF TIME

By Order No. PSC-11-0120-PCO-GU, issued February 22, 2011, the date for utilities to file their PGA projection testimony and exhibits was scheduled for September 13, 2011. On September 13, 2011, Florida Public Utilities Company (FPUC) requested that it be granted a two day extension for filing its projection testimony and exhibits.

In support of its request, FPUC contends that while it has diligently attempted to finalize its projection filing in a timely manner, certain cost information necessary to completing the filing is not yet available to the company. FPUC anticipates that a two-day extension should be sufficient to allow it to complete and file its projection testimony and exhibits. FPUC contacted the parties to the docket and none expressed an objection to the granting of its request.

Upon review, FPUC's motion for extension of time is hereby granted. It appears that no party will be prejudiced by an extension until September 15, 2011, and no party has objected to the extension. Accordingly, FPUC shall have until September 15, 2011, to file its projection testimony and exhibits. This Order is issued pursuant to the authority granted by Rule 28-106.211, Florida Administrative Code (F.A.C.), which provides that the presiding officer before whom a case is pending may issue any orders necessary to effectuate discovery, prevent delay, and promote the just, speedy, and inexpensive determination of all aspects of the case.

Based upon the foregoing, it is

ORDERED by Commissioner Ronald A. Brisé, as Prehearing Officer, that Florida Public Utilities Company's Motion for Extension of Time to File Projection Testimony and Exhibits is granted as set forth in this Order. It is further

ORDERED that Order No. PSC-11-0120-PCO-GU is reaffirmed in all other respects.

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.569(1), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Mediation may be available on a case-by-case basis. If mediation is conducted, it does not affect a substantially interested person's right to a hearing.

Any party adversely affected by this order, which is preliminary, procedural or intermediate in nature, may request: (1) reconsideration within 10 days pursuant to Rule 25-22.0376, Florida Administrative Code; or (2) judicial review by the Florida Supreme Court, in the case of an electric, gas or telephone utility, or the First District Court of Appeal, in the case of a water or wastewater utility. A motion for reconsideration shall be filed with the Office of Commission Clerk, in the form prescribed by Rule 25-22.0376, Florida Administrative Code. Judicial review of a preliminary, procedural or intermediate ruling or order is available if review of the final action will not provide an adequate remedy. Such review may be requested from the appropriate court, as described above, pursuant to Rule 9.100, Florida Rules of Appellate Procedure.
