14 moment. Thank you, Ms. Helton.

15                   So Chairman Graham has moved that we

16 approve the staff recommendation on the Move Staff

17 list that was before us, which would include Items

18 3, 5, 7, 8, 9, and 10. All in favor say aye.

19                   (Vote taken.)

20                   **COMMISSIONER EDGAR:** Opposed?

21                   Show it adopted.
