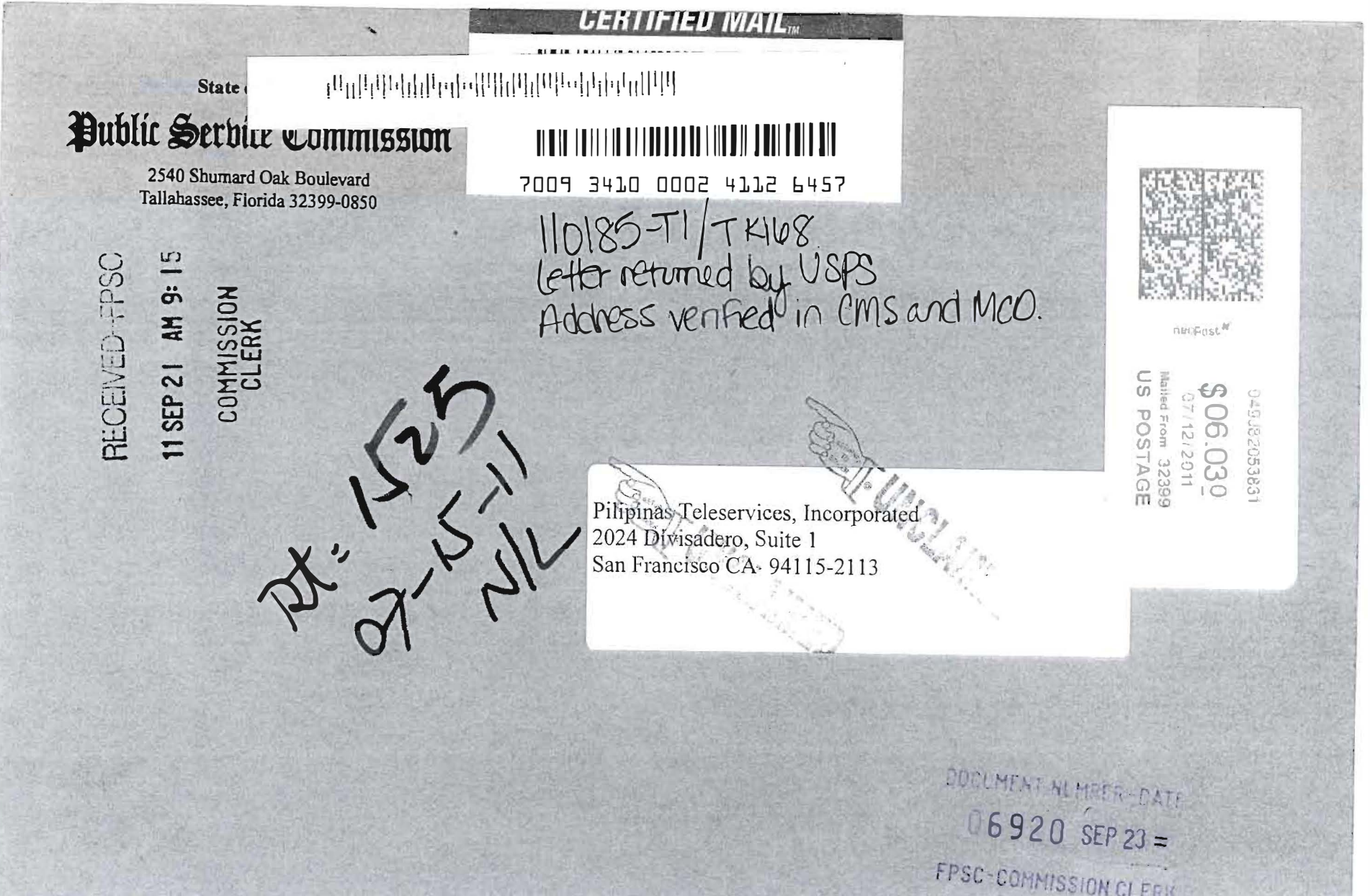

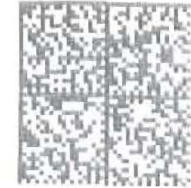

CONSUMMATING ORDER

BY THE COMMISSION:

By Order No. PSC-11-0261-PAA-TI, issued June 17, 2011, this Commission proposed to take certain action, subject to a Petition for Formal Proceeding as provided in Rule 25-22.029, Florida Administrative Code. No response has been filed to the order, in regard to the above mentioned dockets. It is, therefore,

ORDERED by the Florida Public Service Commission that Order No. PSC-11-0261-PAA-TI has become effective and final. It is further

ORDERED that these dockets shall be closed upon receipt of the imposed penalty and cost of collection, together totaling \$1,000, and any Regulatory Assessment Fees, including any statutory late payment charges, from each entity or upon reference of the entities to the Florida Department of Financial Services for further collection efforts.
