Wide Voice, LLC ("Wide Voice" or "the Company") hereby submits its responses to the Commission Staff data request issued on September 9, 2011.

- 1. Is Patrick Chicas, President of Wide Voice LLC, the same Patrick Chicas who was Vice President of CommPartners, LLC and Vice President of MGC Communications, both former Florida Public Service Commission certificated companies? If so, please explain why this information was not disclosed on the Wide Voice LLC application. If no longer associated with company, give reason why not.**

Yes, they are the same person. Mr. Chicas ceased all contact with all CommPartners companies in the second quarter of 2010. Prior to that, Mr. Chicas maintained only an advisory role from first quarter 2009 to second quarter 2010 with little compensation.

- 2. Comm Partners Holding Corporation is an active Nevada Corporation which lists Patrick Chicas as Treasurer and Secretary. Please explain Mr. Chicas' duties with this entity.**

It is Mr. Chicas' understanding that all CommPartners Companies are bankrupt and have been liquidated. Any standing inclusion of his name in any title with any former CommPartners company is in error.

- 3. CommPartners Network Services LLC is an active Nevada Corporation which lists Comm Partners Holding Corporation as a managing member. Please explain Mr. Chicas' duties with this entity.**

Mr. Chicas has no contact and no involvement with these companies. See #1 and #2.

- 4. WideVoice Communications, Inc. is an active Nevada Corporation which lists Patrick Chicas as President and Director. Please explain Mr. Chicas' duties with this entity.**

WideVoice Communications, Inc., is a dormant company that became so when they chose to operate their CLEC assets under LLC formation.

- 5. Does Mr. Chicas have any relationship with CommPartners' Connect? If so, please explain the relationship.**

Mr. Chicas has no contact and no involvement with these companies. See #1 and #2.

- 6. Are any employees, managers, officers or stockholders of Wide Voice LLC formerly employees, managers, officers or stockholders of CommPartners, LLC? If so, please identify each person and their duties at CommPartners, LLC.**

No. Mr. Chicas' only equity in any CommPartners Company was in CommPartners Holding Corporation. That equity is now worthless. See #2.
