8 **RE: NOTICE OF SUSPENSION AND TERMINATION**

9 AT&T's records indicate that the FLATEL, Inc. ("Flatel") Florida Resale accounts have
10 an outstanding past due balance of [REDACTED] as of August 31, 2011. These Resale
11 accounts are listed on Attachment A.

12 The Interconnection Agreement between AT&T Florida and Flatel covering services
13 purchased in the State of Florida, which was approved by operation of law on October
14 17, 2005 (as subsequently extended, the "ICA"), requires you to pay AT&T Florida all
15 billed charges, including disputed amounts. See ICA, Attachment 7, Billing at Section
16 1.4, which reads, in part:

17 **FLATEL shall make payment to BellSouth for all services billed including**
18 **disputed amounts.**

19 Moreover, Section 1.4.1 of Attachment 7, Billing to the ICA requires payment for
20 services prior to the next bill date, as follows:

21 **Payment for services provided by BellSouth, including disputed charges, is**
22 **due on or before the next bill date.**

23 Attachment A shows the amounts AT&T Florida billed Flatel for Resale services
24 purchased in the State of Florida, credit adjustments AT&T Florida applied and
25 payments AT&T Florida received from Flatel since January 2009.
