Dear Commission Clerk:

This letter is a request by Four Points Utility and Bimini Bay Utilities, for the Florida Public Service Commission to grant temporary rates to Bimini Bay Utilities.

Mike Smallridge, as court ordered receiver, has filed Docket # 120080, an Application for Amendment of Certificate 634-W and 554-S to add territory in Polk County by Four Points Utilities Corp and requests the commission approve, subject to refund, the currently approved tariff of Four Points Utilities Corp. for Bimini Bay Utilities.

Currently, Bimini Bay Utilities Corporation is an unregulated utility only charging customers for the cost of water and wastewater from Polk County Utilities. Bimini Bay Utilities has requested regulation from the Florida Public Service Commission so that the utility may recover operating & maintenance and other such related costs associated with the utility.

The next billing cycle for Bimini Bay is the 10th of the month and the receiver requests permission to charge the Bimini Bay Customers the Four Points approved tariff by that date.
