

NOTICE IS HEREBY GIVEN that Florida Division of Chesapeake Utilities Corporation ("CHPK"), by and through its undersigned counsel, pursuant to Section 366.093, Florida Statutes, and consistent with Rule 25-22.006(3), Florida Administrative Code, hereby submits its Notice of Intent to Request Confidential Classification for information contained in its Responses to Commission Staff's Second Set of Interrogatories (Nos. 2-7), which have been served on Staff Counsel today.

Specifically, CHPK intends to request confidential classification of the highlighted customer account information provided in response to Interrogatory 2 and included on Attachment A to the Company's Responses. CHPK treats this information as highly proprietary, confidential business information consistent with the definition of that term in Section 366.093, Florida Statutes.

Release of the referenced information as a public record would harm CHPK's business operations and its ratepayers by releasing specific customer-account information and details, thereby harming CHPK's competitive business operations. As such, CHPK requests that the Commission protect this information pending the filing by CHPK of a Request for Confidential Classification consistent with Rule 25-22.006, Florida Administrative Code.
