Dear Ms. Cole:

On November 18, 2011 the Federal Communications Commission ("FCC") released its *USF/ICC Transformation Order* in WC Docket No. 10-90 et al. With that Order, and subsequent clarification orders, the FCC began a transition to a national framework for certification of Eligible Telecommunications Carriers ("ETCs") required for the ETCs' continued receipt of federal high cost support.

Knology of Florida, Inc. ("Knology") has received federal support only from the Interstate Access Support ("IAS") portion of the federal high cost program. As part of the *USF/ICC Transformation Order*, the FCC froze all federal high cost support mechanisms at 2011 levels and combined them into a single fund. Previously, Knology certified its use of IAS directly to the FCC and the Universal Service Administrative Company ("USAC"). However, beginning in 2012, all state-designated ETCs who receive federal high cost support must obtain that certification from state commissions. For 2013 funding the state must provide this certification to the FCC and USAC by October 1, 2012.

Knology is requesting that the Commission certify by October 1, 2012 that Knology's IAS was used in the previous year and will be used in the coming year for the provision, maintenance, and upgrading of the facilities and services for which the support is intended, in accordance with 47 C.F.R. § 54.314. In addition, for your information, attached is a copy of the certification filed with the FCC on June 8, 2012 as part of Knology's federal ETC filing.

Under the *USF/ICC Transformation Order*, and subsequent clarification orders, ETCs receiving only IAS funds do not have any additional reporting requirements for 2012. However, beginning in 2013, all ETCs who receive federal high cost support will be required to comply with the reporting requirements in 47 C.F.R. §54.313 for their state ETC certification filings.
