Please refer to letter of December 7, 2012, copy of which is attached. January 3, 2013, Clark Yandle and I had a conference call with Lydia Roberts, Andrew Maury, Patti Daniels, Pauline Robinson, Shannon Hudson and others. At their direction, I am submitting this letter to ask the Commission for an extention of one year to complete our Pro Forma I. This will be until November 1, 2013. Last year, 2012, S&L had a very good year, in that the pond cleaning is complete, as well as the videography of our lines. We had extra expenses also, all totally about \$45,000. To complete Pro Forma I, we also need to replace two blowers, which will cost about \$15,000. We do not have an extra \$15,000 at this time. The existing blowers are very adequate at this time, and plan to replace, as directed. We just need a little extra time.

Our conference call went very well and I feel so thankful for all the help your staff has been to us. We discussed Pro Forma II and III, installing an elder valve for non-paying customers, as well as contacting Tim Thompson at Marion Utilities to possibly help with our billing and non-paying customers. He has the water utility at Sleepy Hollow and Patti Daniels offered contacting him with reference to helping us. At this time, we have one account that is delinquent \$6,882.65 and nine others that are in the 90 day plus delinquent status. I do not have a complete tariff, but plan to go online and read, especially Rule 25-30. Since we only provide sewer, we have had no way of knowing when people move in and out.

Your consideration in an extention until November 1, 2013 will be greatly appreciated. Thank you very much,
