On February 17, 2012, Water Management Services, Inc. (the "Utility"), completed its application to the Florida Public Service Commission (the "Commission") for increased water rates, in which it requested a permanent revenue increase of approximately 55% for water service.

By Proposed Agency Action Order No. PSC-12-0435-PAA-WS ("PAA Order"), issued August 22, 2012, the Commission proposed a revenue increase of 38.76% for water service. These increases were designed to allow the Utility the opportunity to recover its reasonable and prudent costs for providing service, and a reasonable rate of return on its investment in facilities necessary to provide such water service. The Office of Public Counsel ("OPC") protested the PAA Order, and the Utility filed a cross-protest of the Order. After a formal administrative hearing the Commission issued Order No. PSC-13-0197-FOF-WU on May 16, 2013 granting a total revenue increase to the Utility of 45.93%.

The increased rates and charges are effective for service on or after June 12, 2013.

The PAA and final rates are attached to this customer notice.

This notice was prepared by the Utility and approved by the Commission Staff for distribution by the Utility to its customers.
