**SECTION 63.71 APPLICATION OF RMVDDS, LLC (dba OMGFAST)**

RMVDDS, LLC (dba OMGFAST) ("RMVDDS"), by its attorneys, hereby requests authority pursuant to Section 63.71 of the rules of the Federal Communications Commission, 47 C.F.R. § 67.31, to discontinue the provision of interconnected voice over Internet Protocol ("VoIP") service in all of its geographic service areas. OMGFAST provides the following information in support of this application:

**I. NAME AND ADDRESS OF CARRIER**

**II. DATE OF PLANNED SERVICE DISCONTINUANCE**

The planned service discontinuance will occur in phases. Subscribers were notified of one of three discontinuance dates: in the initial phase, interconnected VoIP service will be discontinued as of August 19, 2013, or as soon thereafter as the necessary regulatory approvals can be obtained; in the second phase, interconnected VoIP service will be discontinued as of August 26, 2013, or as soon thereafter as the necessary regulatory approvals can be obtained; finally, interconnected VoIP service will be discontinued for all remaining subscribers as of August 28, 2013, or as soon thereafter as the necessary regulatory approvals can be obtained.

### **III. POINTS OF GEOGRAPHIC AREAS OF SERVICE AFFECTED**

RMVDDS seeks authority to discontinue the provision of interconnected VoIP service in all of its services areas, which are located in South Florida. Service will be discontinued first in the following areas: parts of Broward County, Northern Miami-Dade County, and Southern Palm Beach County including, without limitation, communities in Boca Raton, Deerfield Beach, Ft. Lauderdale, Hillsboro Beach, Lauderdale Lakes, Lauderhill, Lighthouse Point, North Lauderdale, Oakland Park, Pembroke Park, Tamarac, and West Park; and parts of Aventura, Hallandale Beach, Hollywood, Miami Gardens, Miramar, Pembroke Pines, and Pompano Beach. Service will be discontinued next for most homes in the remainder of Broward County, including, without limitation, communities in Coral Springs, Parkland, Margate, Coconut Creek, Lauderdale Lakes, North Lauderdale, Parkland and Pompano Beach. Finally, service will be discontinued for all remaining subscribers.

### **IV. BRIEF DESCRIPTION OF TYPE OF SERVICE AFFECTED**

RMVDDS's Broadband Telephone Service is an interconnected VoIP service, *see* 47 C.F.R. § 9.3 (defining interconnected VoIP service). Discontinuance of the Broadband Telephone Service will not adversely affect the public convenience and necessity. Existing customers have a wide range of alternative voice services from which to choose, including traditional wireline voice services, facilities-based VoIP services (*e.g.*, cable or telco VoIP), and wireless voice services.

### **V. BRIEF DESCRIPTION OF THE DATES AND METHODS OF NOTICE TO ALL AFFECTED CUSTOMERS**

RMVDDS notified its customers in the initial discontinuance areas by letters sent via U.S. Mail on July 16, 2013. RMVDDS notified its customers in the second discontinuance areas by letters sent via U.S. Mail on July 23, 2013. RMVDDS notified all remaining customers by

letters sent via U.S. Mail on July 25, 2013. Samples of the customer notice letters are attached to this application. The notices included all of the information required by 47 C.F.R. § 63.71(a)(1) - (a)(4), as well as the statement applicable to non-dominant carriers set forth in 47 C.F.R. § 63.71(a)(5)(i). Copies of this application are being sent, first class U.S. Mail, to the Florida Public Service Commission, the Governor of Florida, and to the Special Assistant for Telecommunications to the Secretary of Defense, pursuant to Section 63.71(a) of the Commission's rules.

#### **VI. REGULATORY CLASSIFICATION**


RMVDDS is considered a provider of interconnected VoIP service and, consistent with the Commission's rules, is subject to the discontinuance requirements applicable to non-dominant carriers.

#### **VII. CONCLUSION**

The public convenience and necessity will not be adversely affected by the discontinuance of RMVDDS's interconnected VoIP service because there are alternative services available to existing customers. RMVDDS respectfully requests that the Commission approve its Section 63.71 Application to discontinue its interconnected VoIP service according to the schedule outlined above.
