ORDER GRANTING DEBTORS' MOTION TO EXTEND THE EXCLUSIVE PERIODS FOR THE FILING OF A CHAPTER 11 PLAN OF REORGANIZATION AND SOLICITATION OF ACCEPTANCES THEREOF

CAME ON FOR CONSIDERATION, the Debtors' Motion to Extend the Exclusive Periods for Filing of a Chapter 11 Plan of Reorganization and Solicitation of Acceptances Thereof ("Motion"). The Court, having considered same, and any response(s) thereto, and found that notice of the Motion was proper, is of the opinion that the Motion should be, and is hereby GRANTED, in its entirety; it is therefore

ORDERED ADJUDGED and DECREED, that the Motion is hereby GRANTED; it is further ORDERED that this Court extends the period during which the Debtors have an exclusive right to file a plan of reorganization by ninety (90) days through and including September 23, 2013; it is

ORDERED that the Court extends the period during which the Debtors have exclusive right to solicit acceptances thereof through and including November 22, 2013, or sixty (60) days after the expiration of the Exclusive Filing Period (as defined in the Motion); it is further

ORDERED that this Order is without prejudice to the right of the Debtors to seek further extensions of the period of time in which the Debtors shall have an exclusive right to file a plan of reorganization and the period of time in which the Debtors shall have an exclusive right to solicit acceptances to a plan of reorganization.
