Please see attached letter from Ms. Ryan. She outlined three questions and concerns of which you should be aware.



After reviewing the following three documents, I would like to inform you of the Summertree Alliance Community questions, concerns and responses for your review before the final PAA Document is issued on January 7, 2014.

- FLORIDA PUBLIC SERVICE COMMISSION VOTE SHEET November 14, 2013 - Docket No. 120209-WS

Issue 1 Written Statement of Commission (page 4): Is the quality of service provided by UIF Satisfactory?

Recommendation was modified with regard to the water portion of the docket; all systems were found to be satisfactory, with the exception of Summertree, which was found to be **unsatisfactory**. The order will direct the utility to work with OPC to develop a customer engagement plan, options, and provide outcomes. Any Problems are to be brought back to the commissioners.

Issue 25 - Should the docket be closed?

Recommendation: No. If no person whose substantial interests are affected by the proposed agency action files a protest within twenty-one days of the issuance of the order, a consummating order should be issued. The docket should remain open for staffs' verification that the revised tariff sheets and customer notice have been filed by the Utility and approved by staff. Once these actions are complete, this docket should be closed administratively.

**CONCERN:

On Issue 1: Will this decision be memorialize in the final PAA document.

On Issue 25: We all thought the docket would stay open regarding Summertree water issues while we work toward and permanent solution. A time frame of twenty-one days of issuance of the order is not a realistic to complete the tasks for our issues to meet the Commission's directive.

Under Case Background on page 3, paragraph 2, sentence 2 states:

On October 28, 2013, the Office of Public Counsel (OPC) filed a Notice of Intervention in this docket, and an order acknowledging intervention was issued on October 30, 2013.5 Prior to the Notice of Intervention, OPC submitted a letter and a CD dated October 25, 2013, composed of customer complaints and protests from the Utility's Summertree customers.

The paragraph 2, sentence 2, statement remains in error in the December 23, 2013 Staff Recommendation Memorandum. We discussed this huge oversight at length during the Commission Conference on November 14. Yet, this document does not the efforts of our community by recording the number of documents submitted by the Summertree community in presenting our water issues to the Commission.

OVERVIEW:

- OPC submitted a cover letter and a backup CD with the e-filings for Summertree Water Alliance Cover letter and over 3,000 Protest Forms to Florida Public Service Commission from the Summertree Residents opposed to 2013 Utilities, Inc. of Florida Rate Increase—Docket No. 120209.

- Secondly, the CD contained e-filing for the Summertree Water Alliance cover letter and over 500 Petitions to Florida Public Service Commission from Summertree residents opposed to 2013 Utilities, Inc. of Florida Rate Increase Docket No. 120209-WS

- Additionally, the governor's office had forwarded to the PSC over 514 letters from the Summertree residents which were sent to Governor Rick Scott informing him of our water issue.

**REQUEST:

We would appreciate the PSC Staff amending this oversight to reflect the Summertree community efforts of the over 4,000 letters, forms, and petitions to be recorded in the final documents.

 - Issue 1 (page 4): Should the revenue requirements and resulting rates, approved by the Commission on November 14, 2013, be revised to correct errors related to the Utility's roll-forward adjustments?
 - **Recommendation: Yes.** The resulting revenue impacts for all systems for this case are reflected below in a chart. The resulting water and wastewater rates from the corrected revenue requirements are shown on Schedule Nos. 4-A through 4-E.
 - Issue 2: Should the initial interim refund calculations be revised, and, if so, what is the amount of any refunds?
 Recommendation: Yes.
 - O Issue 3: Should this docket be closed? Recommendation: No. If no person whose substantial interests are affected by the proposed agency action files a protest within 21 days of the issuance of the order, a consummating order should be issued. The docket should remain open for staff's verification that the revised tariff sheets and customer notices have been filed by the Utility and approved by staff, and that the interim refund for Orange County water has been completed and verified by staff. Once these actions are complete, this docket should be closed administratively, and the corporate undertaking should be released.

Response to Issues 1 & 2:

We were delighted to see that the staff made recommendations for additional adjustments.

Concern for Issue 3: Closing the Docket

We would like to see the docket remain open for Summertree until the permanent solution is achieved to meet the Commission's directive.

Although we have pointed out some oversights, I would like to thank the Commission and staffers for the additional time they have taken to review several issues, meetings with the OPC and Utilities of FL, Inc. to make these additional adjustments.

Thank you for taking the time to review Summertree concerns.
