On February 13, 2015, BellSouth Telecommunications, LLC d/b/a AT&T Florida filed and requested approval of an Amendment to the Interconnection, Unbundling, Resale and Collocation Agreement between BellSouth Telecommunications, LLC d/b/a AT&T Florida and Nexus Communications, Inc. d/b/a Nexus Communications TSI, Inc.

On May 14, 2015, AT&T Florida was notified by the Commission that the above mentioned amendment cannot go into effect by operation of law on May 14, 2015 because the registration for Nexus Communications, Inc. d/b/a Nexus Communications TSI, Inc. was cancelled in Docket No. 150027-TX, Order No. PSC-15-0147-CO-TX.
