Commissioners:

As residents of the Town of Indian River Shores (my wife is a Florida resident) we were thrilled to hear that Florida Power & Light (FPL) is ready, willing, and able to serve <u>all</u> residents of our Town should the Public Service Commission (PSC) grant our request to have service boundaries re-drawn so that our entire Town can be served by FPL. We are fortunate that FPL has confirmed its commitment to serve our entire Town, and Carol and I welcome their participation in this process. We realize that the Commissioners know that FPL has made a significant initial cash offer to purchase the utility system in our Town. This huge is our minds. We believe that there is an extraordinary opportunity here for the PSC to consider the petition by the Town of Indian River Shores of FPL's initial offer and begin discussions toward a mutually beneficial solution.

The constitutional issue before the PSC is not some obscure legal isue on a law school exam but a real one that is harming the people in our community.
