Mr. Szabo,

The Order you attached is called a Consummating Order. All the Order does is finalize the Order that was issued by the Commission on March 28th. The rates that were approved by the Commission in March were NOT final until April 25th, which is the day the Consummating Order was issued. The reason is because the law requires a 21 day period before the new rates and other items in the Commission's Order are final to allow an interested party to protest (or challenge) the Commission's decision.

Now that the Order is final, you will be able to implement your new rates <u>ONLY AFTER</u> you finish the tasks Sonica Bruce spoke to you about on the customer notice and revised tariff sheets. If you have not finished those things, you need to contact Sonica immediately to complete those items before you begin charging the new rates. NOTE: If the Utility begins charging the new rates before completing the required items Sonica spoke to you about, the Utility will be in violation of the Commission's Order and Rules.
