Please file the attached e-mail in the above-referenced docket regarding Sunrise Utilities, L.L.C.'s (Sunrise or Utility) request for an extension to provide written notification that the Utility has completed the Commission-required accounting adjustments and staff's response.

Pursuant to Order No. PSC- PSC-16-0126-PAA-WU, Sunrise is required to provide written notification by July 25, 2016, that the Commission-approved adjustments for all applicable National Association of Regulatory Utility Commissioners' Uniform System of Accounts (NARUC USOA) primary accounts have been made. The Order authorizes staff to administratively approve a request for extension, of up to 60 days, in the event that the Utility is unable to complete the required adjustments by that due date. Pursuant to the Order, the Utility's request for extension is due at least seven days prior to the notification due date, or by July 18, 2016.

By the attached e-mail dated July 15, 2016, the Utility has requested an extension to complete the required accounting adjustments. Staff has discussed the status of the accounting adjustments with the Utility and agrees that additional time is needed in order for the Utility's accountant to properly complete the required adjustments.
