Florida Power and Light (FPL) remains a valued energy provider and has over the many years provided exceptional, reliable customer service, as well as post-outage, quick response.

That being said, FPL's petition to increase its rates will have an absolute adverse economic impact on the many businesses it serves.

Ever since the NASA Space Shuttle Program ended in 2011, dozens of North Brevard small and large businesses struggle to maintain and grow their operations, and to this day, remain in a delicate recovery posture. As a result of FPL's rate increase notice, a dozen companies within the Titusville Spaceport Industrial Park met to discuss what FPL's rate impact would have on the respective businesses, and to consider protective "hardening" options (ie: Community Solar, Nat. Gas technology solutions).

The fact that this "Band of Businesses" met at all, directly reflects the difficult business environment that still persists in the Northern part of the Space Coast.
