



During this time the streets were so dug up you couldnt even get to your home without a 4x4 and you want to talk about the water being off ALL THE TIME. It also brought Inspectors into our neighborhood who forced me to have a tree in the middle of my front yard. Also started checking to see if all fences, sheds, porches, and any other structure were permitted when they were built 20 years ago. Then when it was all said and done the bill went upwards of \$100+ a month cause they included trash, sewer, and every other charge you can think of. When I told them I am on septic so why am being charged sewer. I was told because I have access to their sewer. Who do you think is going to eventually pay for these services. Undoubtedly it will be all of us. Just my life experience and thoughts on the matter.

The state is involved, best part is I did not have to be the one to scream. You at the water company now know to watch your p's and q's. OWNER involvement here would be a nice step, a place to pay our bills in person would be nice. Debbie Valley our new Billing contact seems to be on top of stuff....... So steps in correct direction are being made. Trick is for ownership of sunrise to maintain it, and understand that he's NOT going to make any real money off this system..... It's just too small.
