David & Robert;

The following is response to the questions raised in our telephone conference today:

- Daniel Webster's hourly rate is \$20, and he works between 20 and 40 hours a week.
- \$60,000 is John Keaser's salary, \$48,000 of which is allocated to Bocilla Utilities.
- Breakdown of the \$94,466 in test year salaries (I am waiting to hear back from Ray Flischel regarding this). The reason the numbers did not match might be that you had John Kaiser's entire \$60,000 salary in the calculation instead of the allocated \$48,000.
- 34 meters were replaced in 2016. All work was done in-house, primarily by Daniel Webster.
- As for the additional engineering expense, it is allocated as follows: 10 hours for lead and copper issues, 10 hours for disinfection bi-products and other water quality issues, 30 hours for yearly, ongoing coordination of new chloramine feed system that will require daily monitoring by the Utility and monthly by its engineers to assure that we maintain residuals throughout the year as it begins to retreat EWD water.
- Effective interest rate (I am waiting to hear back from Ray Flischel regarding this)
