14	Item 2 is staff's recommendation on Holiday
15	Gardens' request for approval of Phase 2 rates
16	related to the completed pro forma items.
17	On December 29th, 2015, the Commission
18	approved Phase 1 rates for Holiday Gardens. And
19	the Commission also approved Phase 2 rates upon
20	staff verifying that all pro forma approved had
21	been completed and the utility's submitting
22	documentation of the final costs.
23	Holiday Gardens has requested recovery of
24	recent capital improvements not previously approved
25	by the Commission. And in lieu of filing a limited

1	proceeding, the utility had agreed with staff to
2	subsume these recent capital improvements into this
3	proceeding in order to reduce regulatory lag and
4	rate-case expense. With the new capital
5	improvements included, Phase 2 rates still come in
6	under the budget approved by the Commission.
7	Holiday Gardens has submitted documentation of
8	completion of the Phase 2 improvements, and they're
9	seeking to recover rates for the pro forma items as
10	well as additional capital improvements that were
11	subsumed into Phase 2 of the staff-assisted rate
12	case.
13	There are no intervenors in this docket. And
14	no customers have contacted the Commission
15	regarding this matter.
16	Mr. Smallridge from the company is here and is
17	available to address any Commission concerns. And
18	staff is prepared to address any questions.
19	CHAIRMAN BROWN: Thank you. Excellent intro.
20	And welcome, Mr. Smallridge, again.
21	MR. SMALLRIDGE: Happy New Year.
22	CHAIRMAN BROWN: Thank you. Happy New Year.
23	Commissioners, any questions on this item?
24	And if not, I am ready to entertain a motion.
