3 **MS. GUFFEY:** Item 14 is a petition from
4 Florida City Gas in which City Gas proposes tariff
5 modifications to allow the company to request
6 reimbursement for customer-requested installation of
7 extra flow valves, or EFVs, on the company's gas service
8 facilities.

9 The EFV installations address amendments made
10 to federal pipeline regulations. Staff agrees with
11 Florida City Gas's assertion that customers seeking EFV
12 installations should bear the cost and that those costs
13 should not be subsidized by the general body of
14 ratepayers. There have been no customer contacts
15 regarding this docket. Staff recommends approval.

16 Ms. Keating for Florida City Gas is also
17 available to answer questions.
