by Crooked Lake Park Sewerage Company - Request for Extension to December

31, 2017 to Complete Remaining Phase II Pro Forma Projects

Pursuant to Order No. PSC-15-0142-PAA-SU, issued March 26, 2015, the Commission approved four Phase II pro forma wastewater projects. The Utility has fully completed the two projects related to the wastewater treatment plant modification and electrical control panel replacement, and has partially completed the two remaining projects related to the collection system mapping and cleaning and the force main replacement. On September 1, 2017, Crooked Lake provided the attached request for an extension to complete the remaining two projects. Completion of the projects has been delayed due to scheduling delays resulting from subcontractor labor shortages, weather delays, and emergency work. The Utility has requested an extension until December 31, 2017.

Staff notes that Crooked Lake also provided supporting documentation for the partially completed projects, which is currently being reviewed by staff and will be filed in the docket file under a separate memo.

Please file the attached documents in the above-referenced docket. The docket should remain open pending confirmation that the remaining two pro forma projects have been completed, and implementation of the Phase II rate increase.
