The following are the responses of K W Resort Utilities Corp. ("KWRU") to staff's Data Request dated November 9, 2017.

1. Please explain in greater detail the utility's policy with respect to customer requests to discontinue service when the property is no longer occupied.

Response: Since KWRU provides only wastewater service, it does not have control over the connection or disconnection of water service through disconnection or removal of the water meter. As required by Order No. PSC-17-0091-FOF-SU (pages 67-68), KWRU charges the base facility charge for each KWRU meter. The principle behind this is that as long as there is a FKAA water meter in place, there is a potential for wastewater flow. KWRU does not have the manpower to periodically visit every property where a customer may want wastewater service discontinued, but keeps water service. This is a dilemma faced by wastewater-only utilities throughout Florida and is not unique to KWRU. The base facility charge is intended to cover the fixed cost of operating the wastewater system when no wastewater flows, and any customer who may temporarily want to discontinue wastewater service, will expect that service to be available when they need it. KWRU's rates are based on the water meters in existence, which per its tariff, it is required to bill for based on FKAA water meters. During the last rate case, KWRU was informed by the PSC that it cannot bill outside its Tariff.

2. Please explain in greater detail the utility's policy with respect to continuing to bill customers whose homes were affected by the recent hurricanes.

Response: This question fails to explain "affected" and it is probably safe to say that all residents of the Keys were affected by the recent hurricanes. As it may relate to discontinuance of wastewater service due to temporary uninhabitability of a home, as explained above, KWRU is required to bill the base facility charge to all properties served by FKAA water meters, and be able to serve those residences when they become inhabitable. KWRU has recognized due to the evacuation, customers may be delayed in paying bills and have waived late fees for the last two months to allow customers additional time to pay bills for service. Moreover, according to data collected by Monroe County, of the 1,514 single family homes on Stock Island, 17 were destroyed, of which over half were located at a property that is not connected to central sewer.
